It has been circulating off and on for 25 years, but the only dividends paid on GI insurance are for those policies which are today in force. I receive an annual dividend, which today is enough to cover my premiums, because I have never dropped by GI insurance. d I do not have to make application for it, it just comes along in the mail about the first of May each year.

You can be sure that if such a dividend were to be paid to all WWII veterans it would be amply publicized in every newspaper in the land. But it just isn't so.

Sorry, but I can't use it in Echoes, although I have seen it in one of the 8th AF group newspapers.

INSURANCE REFUND FOR WORLD WAR II VETERANS

WASHINGTON --

A bill was passed in Congress recently which will give all World War II veterans a dividend of \$.65 per \$1000.00 of their G.I. Insurance for each month of service. This refund is due regardless of whether or not the insurance is still carried. The dividend cannot be received unless it is requested.

The Veterans Administration is urging all World War II veterans to apply, regardless of whether any insurance was held. The Veterans Administration will check for eligibility. The refunds are not going to make anyone rich, but a couple hundred dollars is always nice. For example: a veteran who had \$10,000.00 in insurance would be entitled to dividends as follows: 12 months, \$78.00; 24 months, \$156.00; 36 months, \$234.00; and 48 months, \$312.00.

i need his birth date, his birth place, anything about his family, his social security number, his army serial number, where can i get a copy of his birth certificate, a copy of his army discharge, all, or any other inforation about him. my nieces would like to know all about their father, my friend, and brother-in-law.

Dear Loren:

Your letter of 9 August poses a few interesting problems. I do think that with a bit of correspondence you can probably solve them.

Here is all that I know about HAROLD E. CLAYTOR. He was with the original Group at Wendover, and his serial # was 19060635. He was assigned to the 423rd squadron, was an assistant crew chief and worked at one time on the engine change crew. He was a tech sergeant at the time he left the 306th. He may have become a crew chief. I just don't know.

I think you have to begin with a death certificate. You know where he died, I assume, and have at least an approximate date. You will need to write to the county clerk in the county where he died and ask for a death certificate. They will need to know date of death, or approximate, your relationship to the deceased, and ask how much the charge will be, and then send them a check for the proper amount. You probably ought at the same time to pursue a death certificate for your sister, especially if they died in the same place. This should tell you place of birth, his parents, and date of birth. It may also include his social security number.

Go to your local public library and ask the reference librarian for help. She will be able to help you with addresses, perhaps fees for certificates, etc. If you know where he died, you may want to contact the undertaker there who served the family, as he may well have a substantial amount of information obtained from the family at that time. The library there ought to be able to supply you with a copy of an obituary for Harold.

You need to check into your pieces' birth certificates, as they may contain a bit of information that would be useful. The American Legion where he died may also be helpful in assiting you. Did he belong to the Legion or DAV?

Talk with the dibrarian about where to poke around for the Social Security number. Once you have this you can approach the Veterans Administration for any data they may have. Did he possibly go to college after the war? Colleges have lots of information on former students, and can be approached through the alumni office.

Once you begin to unravel things, you may want to check into his baptismal certificate, if possible; any high school records, etc. It was not unusual for people to have their discharge certificates recorded by the country clerk after they settled in after the war. Check into this.

Perhaps you can also find out who were the executors for his estate and Mor your sister's estate. Such a person should be able to lead you to data.

If he lived in California you may be able to drive to the right place and do a lot of the work first hand.

When I write for such things, I am always profuse in my thanks for triubling them, and also enclose a stamped, addressed reply envelope. This makes them think you are serious and also considerate. Don't make someone else pay the postage.

Keep me posted. I will want Harold's date and place of death. I am also interested in how quickly and how much data you can put together.
