Dear Russell:

My mission log shows that on January 3rd, 1945, I went to Hermilheim, Germany, and on January 5th to Niedermendig, Germany. I believe that it was on my last mission that when we climbed through the overcast we could not locate our formation. We saw a formation but when we joined it we discovered that it was from the Third Division. After conference with pilot, we decided that we could go with that group to their target with the gas load that we had, even though I had no maps that would cover that area, as our division was going to another location. We made three bomb runs before we dropped the bombs; and, on the way back, someplace in France, the Third Division planes all landed. We continued on by ourselves and crossed the coast of France at a point south of England. We later turned straight north on a course that would have taken us to London. Four Spitfires came out to look us over, but were satisfied with our colors of the day, etc. We landed at Thurleigh just as we were running out of petroleum.

I have always wondered why the Third Division formation landed and if you have any luck in discovering that information, I would appreciate receiving it. I do not know how much reimbursement to send you so will wait until I hear from you.

It was good to see you and June at the reunion and all of the other members of the 306th.

Mabel and I were married in Lawrence Kansas in 1947 by Father Towle. I enclose a copy of a letter which might be of interest to you. A couple years ago, I received a copy of the letter from a third party (the third party, being a lady who lives in our locality, and who at 17 years of age was a member of the German Navy and was assigned to an antiaircraft battery and who, no doubt, fired at us at times when we were in the vicinity of the North Sea and Hamburg).
