1. ELIGIBILITY SCORE FOR OFFICER PERSONNEL CLARIFIED:

TWX LAD 2-228-C For VIII Fighter Command TWX D-66144 5 Aug is quoted for your info and will be the policy adhered to by this command quote: D-66144 for USSTAF 13G TWX 74920 AUG 4 is quoted for your info, guidance and strict compliance even though this card is presently governed by Red Circulars instead of STO SOP 60: "noted herewith for your information, guidance and compliance is USSTAF message EX75787: "Considerable misunderstanding with reference to theater eligibility score for officer personnel is prevalent in this theater. No critical score for discharge of officer personnel has been established. The ASR Score of 85 was established as a guide only: "However, each officer must understand that his ASR score is to be used only as an aid and guide in reaching a decision. Where the release of an officer from an organization will materially impair the efficiency of the organization to perform its primary mission, or where his services are required for another assignment, the officer will remain on duty as and where required." This subparagraph deals with the officer who has expressed the desire not to remain in the service until the defeat of Japan. In all cases military necessity will be the governing factor. Unless a suitable replacement is available an officer will be retained in his unit regardless of expressed desire and ASR score if removal will impair the units efficiency to perform its primary mission. Expression of individual officers desire to be retained in the service will not preclude declaring such individual surplus to theater requirements with subsequent return to the United States for determination of essentiality. War Department has made no commitment. If officer with score at or above theater eligibility score desires to remain in service major commanders are not required to remove such officer from his unit even though a qualified low score replacement is available."

This latter statement is interpreted to mean that any officer who has expressed the desire to remain in the service during the present emergency has waived his right for consideration for release from active duty until after the defeat of Japan and need not be removed from any unit being

redployed regardless of its categorization and regardless of his IRI score except at the convenience of the commander concerned.
