### MEMORANDUM:

1. MOVIES IN THE POST THIS WEEK:

2. ATTENTION ALL OFFICERS!!! Transportation will be provided to the party Saturday night, 22 Sep 1945, only for dates who have written invitations. Trucks will be sent for not less than 24 hours from a given location. Be sure your date has an invitation and notify Lt Kelly at Extension 45 before noon Saturday, so that transportation can be provided.

3. NOTICE: The KEM lounge is now open to all personnel from 1300 hours to 1630 hours daily.

4. NOTICE: The following letter from Hq "MASH", subj: "Treachery Participation in Black Market Trade", dd 10 Sep 45, is quoted for info of all personnel:

1. This theater is faced with a serious and difficult black market problem which constitutes a distinct menace to the United States control of German economy, is directly in conflict with the United States objective of maintaining law and order, prevents inflation and encourages theft and robbery.

2. In order to combat this black market problem, the support of all military personnel in the zone of occupation is essential. Military government courts and German police courts and agencies reconstituted under United States control have been instructed to prosecute vigorously any violation of German price control or rationing regulations. That procedure will reach the Germans. U.S. military personnel also have a part to play in the battle against the black market.

3. All military personnel are, therefore, advised that they are forbidden:

a. To sell, barter or exchange for services any and all material purchased in Army Exchange stores to Germans and civilians in the U.S. zone of occupation, and elsewhere. Violation of this prohibition is a military offense and will subject offenders to punishment under the Articles of War.

b. To purchase German rationed goods or services. This includes, among other things, food, meals in restaurants, clothing, footwear, textiles, soap, and fuel.

c. To pay more than legal prices for those non-rationed German goods and services which military personnel are permitted to buy. It must be remembered that the mark is worth several times to the German what it is worth to the U.S. Soldier.
