## Dear Miles:

You asked me at the reunion about Clayton Wildstein, so I have looked into the matter as far as I can. I have searched the CD national telephone directory that I have and have been unable to locate him.

I did find a C. Wildstein in Florida, and talked with her. She said she had known of a Clayton Wildstein in North Miami Beach who was a CPA. I called information and came up with nothing there.

My record shows he was with the original group and was a correspondence clerk in the personnel office. He transferred to the 367th squadron 19 Feb 44 and was sent to gunnery school (at The Wash) 27 Mar 44. On 25 Apr 44 his MOS was changed to 612, which indicated he had flown several missions by then.

He earned an Air Medal and three oak leaf clussters, and on 1 Sep 44 received the DFC, which probably indicates about when he completed his combat tour. I also checked mission reports for the first half of August and found him flying regugarly with Williams Mc Neil's crew as a ball turret gunner. Must have received a little on the job training for this.

I don't know when he flew his final mission or how many missions he flew.

Nothing in my record indicates a transfer to the 305th BG, and L find no reference as to when he may have left the group.

Hope you and Phyllis have recevered from the rigors of the reunion, and now its on to Savannah in 1998/
