Said to my wife Kay, wonder who sent this to me? A few days later your letter arrived with two issues of the Echoe. I did apply for membership at the 8th. reunion in St. Louis, but, never received any material such as application form ect.

April 1978 and April 1979 was elected Department Commander for the above organization. I did not run this year as I intend running for the seat of Southwest Region Director. I retired in 1976 and have since devoted my time to this organization, as I'm sure you are aware, to do a decent job, one must give 100% effort.

If, I am elected as a director, will have plenty of spare time as this position is not as demanding. I am offering what assistance you may require in you endevor to complete your research. In my file there are thousands of names of those men that were held prisoner in Germany, many of the addresses are not current. 

I appreciate your offer of telp, and also the information which you included in your letter. I have waited several days to answer, as a computer printout was in process. I received it today, and am forwarding you a copy of it.

On most of the names we have appended squadron numbers, and some are marked as FR. or friend.

This is our current list, plus an additional four, we have located since last week. The list continues to grow, although not as rapidly as it did several years ago. But it is amazing how we find them.

I have worked on it rather intensively for the last five years, and a lot of help has come from a lot of people.

We will certainly appreciate anything you can do.

I am also enclosing a Search List. This has been pretty well worked over in your area, principally by a former POW. Jim Vaughter of the Sacramento area. But you may be able to bring about some results too. I mail the missing pages later.

As we earry a "Deceased" list in Echoes, we also want those names, and it gets them off our search list.

Over the period I have developed a card file, with more than 9000 cards in it on 306 people. I don't claim to have all names, but I would guess that I now have about 95%. Which brings to mind, I don't have a card on Ed Seabourn.

I read with interest the article you included in the July issue of 306th Echoes about my husband Charles being elected national senior vice commander of the American Ex-Prisoners of War, Inc. (AX-POW). It occurred to me you would be interested in an update of that article as well as some other information which would be of interest to some of your members who also were POWs.

Charlie is now National Commander of AX-POW. He was elected by acclamation at AX-POW's national convention in July at Colorado Springs. Busy but rewarding.

Of possible interest to some of your members is that AX-POW received its national charter on August 10th. It is Public Law 97-234. The membership is now over the 17,000 mark and growing. Probably a factor in the current influx is the passing of Public Law 97-37 last August (1981) which is the health bill affording the former POWs broader coverage of medical attention than previous to its passage.

Thanks for the article on Charlie, there aren't too many of Ritland's crew left.

C. Miller Elevated To Commander

Charles F. Miller, formerly of Bridgeton, was elected national commander of the American Ex-Prisoners of War Inc. at organization's national convention held recently in Colorado Springs, Col.

Prior to his election to AX-POW's highest office, Miller held the offices of senior vice commander, junior vice commander and southwest region director all on the national board of directors, as well as serving as state commander of the California department for two terms. In addition, Miller started an AX-POW chapter and was its commander for two years in San Diego, Calif.

Miller, a gunner on a B-17, was taken prisoner when his plane was shot down during a bombing raid over Germany.

On Aug. 10 Public Law No. 97-234 was signed into law which grants a national charter to the AX-POW, giving the organization the same national status as the American Legion, the Veterans of Foreign Wars and the Disabled American Veterans.

AX-POW counts among its over 16,000 members men and women, military and civilian, who were held captive by the enemies during World War I, World War II, Korea, and Vietnam.

During his years of membership, Miller has actively participated in the many endeavors of the organization, such as the 1981 passing of Public Law

No. 97-37 which-in brief-gives former prisoners of war entitlement to much needed medical care in areas that previously were not considered valid claims due to the difficulty establishing the correlation between being held a prisoner of war and the disabilities.

Miller plans tentatively to hold the **AX-POW** annual Midwinter Conference and a Medsearch seminar in New Jersey in January 1983. He hopes at that time to meet with many exprisoners of war who still live in this area.

Miller is the son of Sara Foster, a longtime Bridgeton resident who now resides in San Diego. Miller and his wife, Catharine (Jattros), also from Bridgeton, live at 1115 Skylark Drive, La Jolla, Calif. 92037.

Dear Russell:

First, wish to tell you what a great surprise to receive your phone call.

Sorry, it has taken so long for me to acknowledge the arrival of the book for Seaborn, it arrived on the 30th. in good shape. My 92 or 93 year old mother had another mini stroke and we had to take her out of the rest home to the hospital. The 1st. of April was our 44th. wedding anniversary, been spending all these years trying to figure which one was really fooled. Of course getting married 9 days before going over seas lead to much yakking from family and friends such as, "It won't last" perhaps they are right? We were married in Salina, KS. but grew up just five blocks from one another in south Jersey.

Enclosed is a picture you asked for, with all the pictures around here you'd think I'd come up with no one else in it. Sorry but couldn't do it. Also enclosed is the information you requested concerning the American Ex-Prisoner of War Organization. Don't know what you want but trash any of it you see fit.

Over the years belonging to this organization has offered me opportunities I other wise would not have had. Studs Terkel came here a few years back and interviewed me for his up-coming book at that time "The Good War" this led to an invitation to participate in a program for PBS, this was produced by the University of California San Diego. The title is, "Remembering War a U.S.-Soviet Dialogue" It was a Space Bridge project. Must say, it was very strange being face to face with the Russians and speaking with them, even tho we were miles apart the very screens gave one the feeling we all were in the same room. I since have contacted by a Jillaine Smith whose boss Helene Keyssar is now co-writting a book with Vladimir Pozner who also was the Russian moderator, we had as our moderator Frederick Starr, President of Oberlin college. Sorry I got carried away on this subject.

Just wrote a letter to Lawrence Huschle of the 423rd. He is seeking some long lost friends so told him about your book recommending it very highly. He was on the same crew as Earl Mason, the man I asked you about. Hope he sends the loot and purchases a book, therefore by word of mouth to his friends you may end up with many more sales, sure hope so.

Take care and thanks for the added ammunition I will use against ole Seaborn. Your information on your trip to England had Kay and me trying to make arrangements to go but, we already have made reservations to attend the Calif. POW convention on the 22nd. May. Will you be going again?

Camps where held: 7-A---17-B---Luft 1 (this was an officers but in April 1944 the Germans moved 18 Sgts. here) Luft-6---Luft 4---Luft 1 (as Russians advanced the Germans moved many back to Luft 1 where we were liberated by the Russians May 1945.

EX-POW organization now has well over 30,000 members.

There are 27 Departments and 276 chapters.

A national convention is held once a year---There is a directors meeting 6 months before this. The brochure explains how national convention rotates.

Depart. also have a convention once a year.

We now have an office in the VA Regional office Washington, D.C., this is not the same office as pointed out in the brochure.

Having Nat'l. Cmdr. I received many letters from former POW they were not receiving the medical attention according to laws by the Congress giving the EX-POW benefit of the doubt concerning their illness. We had no records to back our claim certain medical and mental problems did in fact occur either when held or were after effects due to captivity.

After leaving office I ask that the board establish a committee of two, Kay & I. to be a liaison between our organization and the VA, this they did. Together we have been able to establish therapy groups throughout the country, at the present I believe there are over 80 such groups. At the time I was cmdr. to the best of my knowledge there were two. We now also have a support group for the wives.

We have no obligations so volunteer our time. It sure makes one feel good when someone tells you your efforts has made life just a little bit better for them.

Question: Are there any other reunions for the 306th. people except the national reunion? I have never heard of it if there is. If not, would it be feasible to have mini reunions? Such as within a region or, a state. No big deal more or less a place where we could meet and just visit old friends spend a week-end and be on our way. It has been my experience when setting such conventions up, many of our people just can't afford the expense of flying, hotel rooms etc. Just thought it may create an interest.

Thanks for the item concerning the POW Medals published in the October 86 Echoes.

If, there is anything I can do to give you a hand, please let me know.

This sad news explaine our absence at 306th get together here in Son Diego. I would appreciate your letting Russel Strong, know of Charlie's passing.
