2. DISCHARGE-38 YEARS OF AGE: Following message from 1st Air Division is quoted for your information and compliance. Report required will be submitted so as to reach this headquarters not later than 25 Aug 45. quote.
For message ISC UK-1391 Aug 20 fr USAF is quoted for your information and compliance. Report will be submitted so as to reach this HQ not later than 27 Aug. JC personnel will be listed separately.

"Notification has been received from War Department that Sec II Cir 151, 1945, has been superseded by new circular now being published which provides that: 'Every enlisted man or woman 38 years of age or over whose service is honorable and who voluntarily applies in writing to his or her immediate commanding officer for discharge will be sent to separation center as provided in current instructions for discharge under the provisions of AR 615-365 (Convenience of the Govt) and this Circular. Military necessity or other requirements or limitations will not be bar to discharge however this authority will not be used in lieu of disciplinary action nor when discharge under other Army regulations is appropriate nor when the individual concerned is under medical or surgical treatment. Commanders will be permitted to retain for 90 days any individual for whom replacement is not available at the time he or she requests discharge. Sec II WD Cir 151, 1945, pertaining to the foregoing subject is rescinded. Desire this HQ be advised not later than 31 August 45 number of personnel so desiring discharge under above provisions, by months of availability.'
