NOTICE: Following message from AFM IAD is quoted: "Enlisted personnel assigned to this theater who have ASR score equal to or above the appropriate critical score and who have satisfactory records may volunteer for continued duty in this theater for such length of time as the services of such individuals are required but such period of time will not exceed the duration plus 6 months. (Note: For interim purposes initial date of duration is 14 August 1945.) When it is determined by the Theater Commander that services of such individuals are no longer required, such enlisted personnel will again be made eligible for return to the United States under the provisions of redeployment regulations. The following statement will be entered under remarks administrative in the service record over the signature of each enlisted person volunteer: 'Regardless of the relationship of my adjusted service rating score to the present critical score and such changes as may be made in the future, I elect to remain in the Army as a class 2 volunteer.' Attention of all personnel concerned will be drawn to fact that class 2 volunteers will be released no later than 14 February 1946 and before that date if concurrence of commanders having assignment jurisdiction is obtained." SUGGESTION BOX:

SUGGESTION: "Suggest that the Senior Officers who have transportation vehicles to go to town when necessary, fill up their vehicles and quit leaving personnel standing around here or here to get a lift. On three occasions I noticed two Senior Officers proceed through the gate without even thinking about getting a ride."

REPLY: Your suggestion is good but it applies not only to Senior Officers but to all. However, it is known that Senior Officers have transportation to go to town for their own convenience. Use of transportation off the station by anyone for personal use is contrary to the Station Commander's policy; furthermore steps have been taken recently to see that such misuse of vehicles does not occur.
