Flying control will receive contents of this msg. from either of the above sources - and relay same to ATC ~~take-off~~ ~~scheduled~~ ~~for~~ ~~flights~~ ~~to~~ ~~affected~~ ~~area~~ ~~before~~ ~~take-off~~. Each ATC will acknowledge receipt of weather msg. before commencing airborne.
